
Project Description: Install vinyl sign on storefront door

Applicant proposal:

The applicant proposes to apply a 2.5-square-foot vinyl sign to the storefront door.

Staff Recommendation:

Approval based on the Design Guidelines Chapter 9

The Historic Districts Design Guidelines state "Signs are a vital part of the commercial areas of Petersburg's historic districts. A balance should, therefore, be struck between the need to call attention to individual businesses and the need for a positive image of the entire district."

The Design Guidelines state vinyl signs are acceptable as long as lettering is appropriate and professional and note consideration should be given to using lettering styles that relate to the era of the building's architecture while ensuring the sign can be read at a distance. The guidelines recommend using colors that complement the color scheme of the building on which the sign is placed. While the lettering and coloring of the proposed sign may not be a direct match for the building and period, it is reflective of the business's existing branding only 2.5 square feet in area which will create a major visual impact.

The Guidelines also state signage should not obscure more than 20 percent of any glass surface; dimensions and placement of the proposed sign would not exceed this limit.

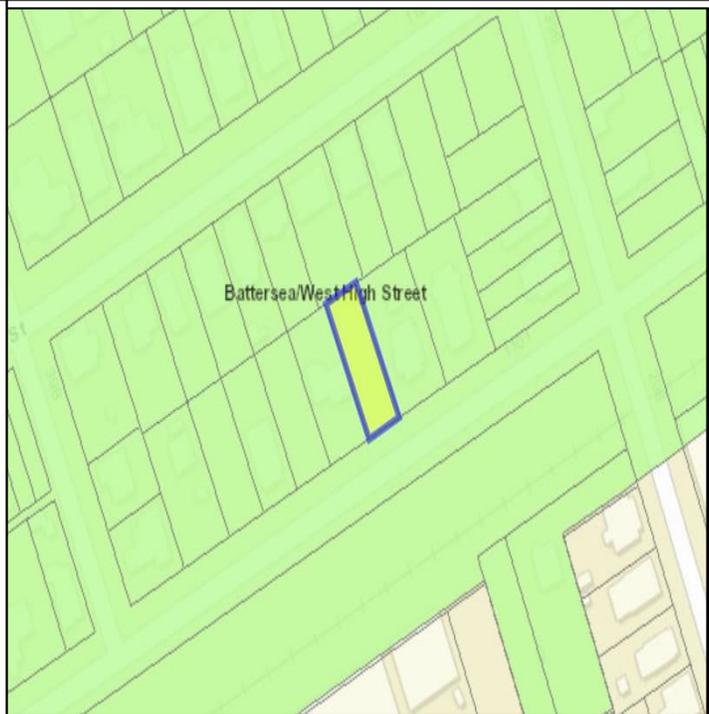
Project Description: Construct new single-family dwelling on vacant lot

Applicant proposal:

The applicant proposes to construct a 1,680-square-foot, single-story dwelling on the lot. The proposed dwelling features horizontal Hardie Plank siding, a dimensional asphalt shingle roof with ridge vent, a covered front porch with Richmond style railing, and painted stucco foundation wall. Double-hung Fibrex-coated windows from the Andersen A Series are proposed. The proposed dwelling is approximately 16 feet tall at the roof peak. The home would be located 28.5 feet from the front property line, and an exposed aggregate concrete driveway is planned.

Staff Recommendation:

Approval based on the Design Guidelines Chapter 7

The Historic Districts Design Guidelines state the most important criteria for new residential construction are “setback, spacing, general massing” as well as relation to neighboring structures, particularly in regard to roof and porch form.

While the homes immediately adjoining the proposed dwelling are 1.5 stories, there are several one-story residences on the block and the massing of the home does not appear out of line with existing structures. The proposed setback from Upper Appomattox Street is comparable to most of the existing homes and conforms to the recommendation of the Design Guidelines. Several residences on the block have asphalt shingle roofs and, in general, the proposed building materials are acceptable, including the Hardie Plank siding, wood composite windows, and Richmond-style railing. Most of the neighboring lots do not include a driveway, but the proposed driveway is acceptable per the Design Guidelines.

The Board should consider the front-gable orientation of the roof. This does not match the existing homes on the block, but staff would note the narrowness of the lot would likely preclude a side-gable orientation due to the setback requirements of the Zoning Ordinance.

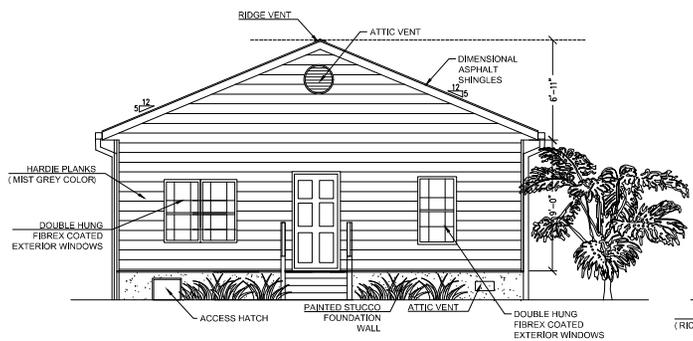

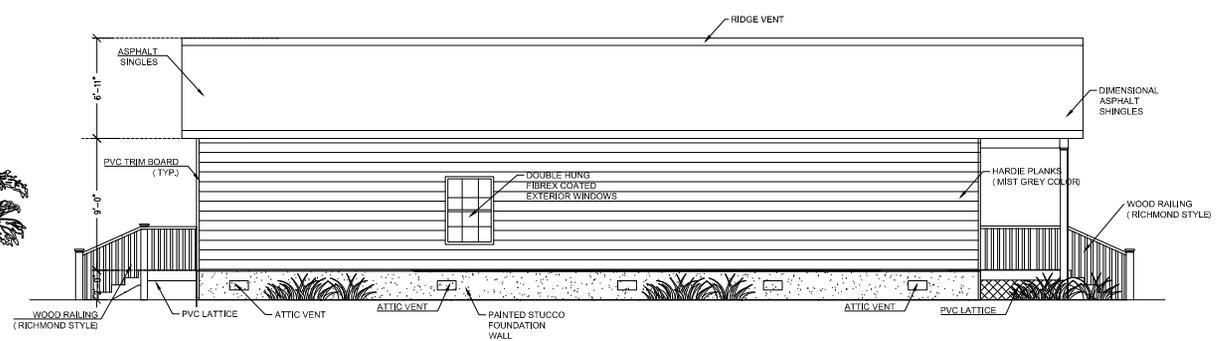
FRONT ELEVATION
